Specifications, photos, appraisals, certifications and other information are also available on the auction listing page.

The USMS had the diamond appraised by a certified professional gemological appraiser to provide a description and determine the value of the diamond. The USMS also researched the provenance to determine authenticity of the diamond. Based on the research and findings the USMS has determined the following:

- NO Mine source origin and cannot associate the diamond with any specific mine.
- NO United Nation resolution sanctions or Kimberley Process claims relating to the diamond.
- NO International government claims or encumbrances relating to this diamond.
- NO relationship or connection to the “Greater Star of Africa” diamond, “Du Toit” diamond or any other known famous historic diamond.

This stunning 43.51 carat diamond spans an impressive 1.42 length to width ratio. The modified rectangular brilliant cut, fancy intense yellow color and internally flawless grade make this diamond a one-of-a-kind beauty. It has a pure yellow hue with no green or orange modifying color and the color distribution is very even with no visible zoning present. This diamond has been authenticated and certified as documented in the GIA REPORT 15154097, dated June 8, 2011. Refer to
